

## INFORMATION ON THE AUGLAIZE COUNTY - JUNIOR FAIR BOARD ELECTIONS

### PURPOSE OF THE JUNIOR FAIR BOARD:

The primary purpose of the Junior Fair Board is to plan and promote the Junior Fair which is part of the Auglaize County Fair. The Junior Fair Board is responsible for seeing that all Junior Fair exhibits are neatly displayed and judged.

### PROCEDURE FOR JUNIOR FAIR BOARD ELECTIONS:

1. The Junior Fair Board shall consist of fourteen (14) Agricultural representatives and fourteen (14) Family and Consumer Sciences representatives plus five (5) at large members.
2. The members are to be elected for a term of two years and so elected that one half of the members are elected each year.
3. In order to accomplish the two proceeding items the following plan will be used in 2020 elections for the Agricultural representatives:
  - A member shall be elected from the following townships for a two year term: Noble, Moulton, Goshen, Pusheta, Salem, St. Marys, Washington.
  - A member shall be elected from the following townships for a one year term: German, Jackson, Logan, Union, Wayne.
4. In order to accomplish the two proceeding items the following plan will be used in 2020 elections for the Family and Consumer Sciences representatives:
  - A member shall be elected from the following townships for a two year term: Clay, Duchouquet, German, Jackson, Logan, Union and Wayne.
  - A member shall be elected from the following townships for a one year term: Goshen, Moulton, Pusheta, Washington.
5. The annual election of the directors of the Society shall be by ballot held on the fairgrounds from 9:00 a.m. to 4:00 p.m. on the days of 4-H Livestock Interviews, Nutrition and Special Interest pre-fair judgments, 10:00 a.m. to 12:00 noon on the day of FFA Shop & Crop Judging, 1:00 to 4:00 p.m. on Sunday of fair and from 9:00 a.m. to 12:00 noon on Monday of the fair in the Junior Fair Board Office or location determined by the board of directors.
6. Voting shall be limited to members of the following organizations: 4-H Clubs, Vocational Agricultural Groups, Vocational & other Family and Consumer Science Groups, Boy & Girl Scouts units, Farm Bureau Councils and Juvenile Granges.

### WHO CAN BE A MEMBER OF THE JUNIOR FAIR BOARD?

Any Auglaize County boy or girl that is fifteen (15) years of age by August 1 of the current year and meets the following qualifications:

- Is a member of a 4-H club, Vocational Agricultural or Family and Consumer Science Group, Juvenile Grange, Boy or Girl Scouts units, or Farm Bureau Youth Council.
- Is nominated by one of the youth groups.
- Receives the highest number of votes in his township.
