### Notes From the Office

#### Dear 4-H Family:

As another 4-H year comes to an end, I hope that your family has shown your appreciation to the people who contribute their time and talents to our program. Some final notes for 2017.

### NEW: 4-H Age Policy

Ohio 4-H membership is based on a child's age AND grade as of January 1 of the current calendar year. Eligibility for Cloverbud participation begins when a child is age 5 and enrolled in kindergarten. Eligibility for participation in 4-H projects and competitive events begins when a child is age 8 and in third grade. Any youth age 9 or above is eligible for project membership, regardless of grade level. Membership requires enrollment in an authorized Ohio 4-H club or group under the direction of an OSU Extension professional or an approved adult volunteer. A youth's 4-H eligibility ends December 31 the year he or she turns 19. Joining Ohio 4 H is a privilege and responsibility for individuals and is subject to the Ohio 4-H Code of Conduct and applicable policies of The Ohio State University.

#### **OUALITY ASSURANCE - 2018**

There is a major change for Quality Assurance in 2018. A new law will state that "junior fair exhibitors shall successfully complete the educational program not less than 45 days prior to the opening date of the exhibition in which they will participate." What this means:

- \*This rule will become part of the Ohio Revised Code. Therefore, it's the law, we have no ability to grant exceptions.
- \*All required members MUST be certified for QA 45 days prior to the opening day of the county fair. There will still be the test out option for members 12 and over as of January 1 (45 days prior still applies).
- \*This rule also applies to members exhibiting at the Ohio State Fair, they must be compliant by the opening day of state fair. Since there is only a 4 day gap in the opening day of Ohio State Fair and our fair, it seems to make sense to meet the state fair date. By using that date as our deadline, we can cover both state fair and county fair exhibitors. So tentatively we are saying that all QA will need to be done by June 10, 2018. That date will be confirmed soon. MARK YOUR 2018 CALENDARS!!
- \*In the past we have sometimes conducted a late QA program for a fee, that will no longer be an option. NO MORE LATE QA because there can be no exceptions past when the law says QA must be completed for our county. There is no "grace period" so to speak. In addition, the week that the QA deadline falls is our camp preparation/day camp week, so there is no staff time to offer any extra sessions.
- \*We will still hold 3 testing dates and 3 program dates as in the past dates will be released in a few weeks. All testing and program dates will be prior to June 10 (so no more late June program). When these dates are released, make a family plan to guarantee your children can get certified.
- \*Please remember no QA = no entry = no fair exhibition.

A few other notes regarding QA:

- +Members going to state events such as Beef Expo, Junior Swine Day, Dairy Palooza, etc. may complete their QA certification at these events. I will receive notification that they have completed. (Please see next note.)
- +First year QA project members between the ages of 8 and 11 are required to have a parent attend QA. If a member is going to a state event (or another county), the parent requirement still stands <u>parent must show written proof of attendance of the OA portion of the program from the event sponsor.</u>
- +Members are required to receive prior permission to attend a program in another county.
- +Full time participation is required for QA programs arriving 20 minutes late or leaving 10 minutes early is not permissible and can result in the child having to attend another program or not being certified. This has become a frequent problem and will not be ignored in the future. Members should be in line no later than 6:45 for registration for programs.
- +Quality Assurance is required for members exhibiting: market steers, market hogs, market lambs, market goats, market rabbits, market turkeys, broilers, lactating goats and lactating dairy cattle.
- +Quality Assurance rules are part of the Ohio Revised Code it's the law not a fair rule.
